THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO SET ASIDE THE CIRCULAR DATED:13.5.2020 ISSUED BY THE R-1 HEREIN AS ANNEXURE-H AS IT IS VIOLATION OF THE CENTRAL GOVERNMENT OFFICE MEMORANDUM DATED:14.9.2020 EXEMPTING EMPLOYEES WITH DISABILITIES FROM ROSTER DUTY DURING THE COVID-19 PANDEMIC AND DIRECT THE RESPONDENTS TO EXEMPT GOVERNMENT EMPOLYEES WITH DISABILITIES ROASTER DUTY AND TREAT AND SAME AS SPECIAL PAID LEAVE AND ETC.

THIS PETITION COMING ON FOR ORDERS THROUGH VIDEO CONFERENCING THIS DAY, **CHIEF JUSTICE** MADE THE FOLLOWING:

## **ORDER**

The learned Additional Government Advocate states that on 5<sup>th</sup> January 2021, pursuant to the decision taken by the State Government, a circular has been issued stating that all Government employees who fall in the category of disabled and visually challenged will be entitled to work from home. He states that the said circular is applicable to all such category of Government employees. This circular will take care of the main grievance made in the petition.

- 2. The other submission of the learned Senior Counsel appearing for the petitioner is that as the circular will apply prospectively, in case the said category of employees who could not report to duty in the past, the said period should not be treated as a leave without pay. Reliance is placed on the Office Mernorandum dated 28<sup>th</sup> April 2020 (Annexure-D) to the petition issued by the Government of India.
- 3. As of today, there is no material placed on record to show that any such employee who belongs to the aforesaid category and who could not attend to duty during the lockdown or pandemic was treated as if he was on leave without pay. In case that question arises, we are sure that the

State Government will take appropriate decision in the light of the Office Memorandum dated 28<sup>th</sup> April 2020(Annexure-D).

4. With the above direction, the petition is disposed of.
